SEWAGE CHARGES MOVE TO "USER PAY"

Recently, Saanich Council approved changes to the sewer billing to better reflect the amount each user pumps into the system.

Until now, sewer charges have been based on a combination of a parcel tax, assessments and the number of fixtures in a property. This system bore little relationship to the amount of sewage users actually produced and resulted in considerable inequities.

A single person or a couple in a large, family home would, for example, pay far more, proportionately, then a business such as a restaurant or an institution such as the University of Victoria.

Under the new system, which will be phased in over 3 years, each user will pay a small fixed charge of \$31 per year. The rest of their payment will be based on actual use (amount of sewage produced).

Amount produced will be based on the lowest of rainy season bills, so the effect of summer watering will be eliminated and you won't be penalized if you have a large garden.

The new system will be fairer and will bring Saanich billing into line with the rest of the region. As an added bonus, the new system will promote conservation.

THE SEED FARM COMES TO THE FORE AGAIN

You may recall about five years ago, Western Forest Products sold its seed farm at the end of Beckwith in the Blenkinsop Valley. Since then several owners have floated a number of proposals past our association.

However, with Council making it evident that they were loathe to approve any development in the valley, no development proposal has yet gone forwarded for consideration by Saanich.

Now, a new owner, the Merdyn Group, is attempting to develop the site. In October of this year, they held a meeting for the immediate neighbourhood which a few members of our executive attended.

At that meeting, some community members were concerned that the association had not informed them of what was happening. That's because the association itself did not find out about the meeting until the last minute.

The developer involved has experience in Saanich and it is in our mutual interest that he works with the community and gets them involved as soon as possible.

We hope that in the future, the developer will make every attempt to keep the association involved. In turn, as the developer works with us, the association will do its best to insure that the community is informed. We have already informed the developer of traffic and land use concerns.

This proposal will likely face the same obstacles as earlier proposals that did not proceed. Most of the property is outside the urban containment and the sewer containment boundary. In addition, some of the land is ALR and the Blenkinsop Valley is regarded as very special in our municipality. Change to the valley, if there's to be any at all, must be carefully considered.

MAYOR LEONARD'S STREETSCAPE SAFETY INITIATIVE

On Monday, November 20th, Mayor Leonard brought a report to Council dealing with streetscapes. This report may have stemmed from a backlog in projects that has developed in Saanich over the years.

For some time, Council followed a process of approving streetscape designs without ever providing capital in the budget to carry them out.

Eventually, a backlog of about 15 projects built up. In Council's last term, agreement was reached to do at least 3 streetscape projects in 10 years. However, a quick calculation shows that, at that rate, a half century would be needed to catch up to already accepted designs. Faced with all of this, the mayor has suggested that streetscapes should be limited to safety and "operational" concerns.

According to staff, operational concerns covers problems such as whether left turn lanes are of sufficient length and have been primarily directed at the flow of traffic. Safety, on the other hand, is automatically a part of everything that Saanich does to streets but things can be safe without being attractive or very functional.

Limiting streetscapes to safety and operational concerns would seem to

suggest future projects leading to the same "hard edged" unattractive, automobile oriented solutions that we have had too often in the past.

Good streetscapes can provide much more. Well designed, integrated streetscapes can provide desirable pedestrian environments that encourage residents to get out of cars and walk. Furthermore, they can help with traffic calming and can offer environmental benefits including better treatment of stormwater. On the economic side, attractive, modern, vital streets will encourage investment in the municipality. Ugly, "hard edged" streets will do just the opposite.

It would seem that many others agreed with this point of view. When the item came before Council on Monday, November 20th, over 30 people, including most community associations, attended and spoke to Council. All but one opposed the mayor's initiative. Also, opposed were several letters including one from a prominent architect with recognized expertise in smart growth.

Surprisingly, Council voted to approve the narrow definition of streetscapes with Councillors, Brownoff, Derman and Sanders voting in opposition. Our association sees this as a backward step for Saanich. We hope that you will urge the mayor, and Councillors who voted with him, to reconsider.

DEVELOPMENT PROPOSAL FOR 4045 RAINBOW

Recently, the association met with a developer who has big plans for the southern slopes of Christmas Hill on the east side of Rainbow.

The developer involved had originally purchased the old Penn property at 4045 Rainbow. Recently, he added 4021 Rainbow and 820 & 850 McKenzie to his holdings. This gives him ownership of most of the land east of Rainbow from the edge of the nature sanctuary to Mckenzie.

In addition, to being next to the sanctuary, the properties in question currently contain considerable green space as well as a large number of Garry Oaks. The land must be developed very sensitively, if natural values are to be retained.

DEVELOPMENT PROPOSAL FOR 4030 BORDEN

For some time, we have been working with a developer on a proposal for properties at 4030 Borden near the Monkey Tree Pub. We have passed the following concerns on to the applicant:

- We would like assurance that parking numbers will work.
- While the target audience is young people including university students, we are not sure they will not own cars.
- We have concerns about locating large numbers of students next to a pub.

- Presently staff at the Monkey Tree park on this property. How will their parking be addressed?
- Streets in the area cannot handle more on street parking
- We would like more information on how this development would meet "green" development initiatives in Saanich.
- How does this development provide for bike storage needs.
- How will access to the Lochside Trail be improved and integrated into project plans?

- The proposed traffic circle should be the minimum amenity provided.
 More detail is needed on how it will work for emergency vehicles etc.
- We would like more details on stormwater management.
- We have concerns that the density is too high for this location.
- We would like to see the development to become part of an overall concept plan for the area including the Saanich yard.

We will continue to press for answers to these questions.

SIDEWALK FRUSTRATIONS

While we thank Council for the North Qaudra Traffic Management Study currently being implemented, we remain concerned about the poor quality of sidewalks in our area. Specific concerns include:

- Still more improvements are needed near Lakehill and Rogers schools.
- A lack of separation from the road through curb or boulevard barriers for the new sidewalk on Douglas between Cameo and Lily.
- The continued existence of the very poor quality sidewalk on Morris/Cedar Hill/Borden that do not accommodate those with mobility challenges.
- The very poor quality of the pedestrian environment along much of Quadra which will be addressed in the next newsletter.

As a municipality, we must do better!
